**Re:** ***NOTICE OF LIABILITY and DEMAND that you CEASE AND DESIST from your role in attempts to compel my vaccination for COVID-19***

**I DEMAND THAT YOU CEASE and DESIST** – from your role in measures taken to coerce and compel my vaccination with the mandated vaccine compounds, whether through direct participation, promotion, persuasion, encouragement, cooperation, acquiescence and/or compliance in these measures.

**NOTICE OF LIABILITY** – You will be held accountable for the harms you are causing me, which will include but not be limited to harms to my life and health if I submit and receive the mandated vaccines; or harms to my career, livelihood and health if I refuse.

I am not suggesting that your participation in the attempt to compel my vaccination is necessarily ill-intentioned. You may believe that you are right in closing your eyes to the improprieties – and the risks even to yourself of the mandated vaccine program – in service of the greater good.

However, what is illegal and immoral by the standards of national and international law, cannot result in a greater good. At this point, the staggering vaccine [death](#) and [injury](#) toll – the people killed and permanently injured by the vaccines – ought to give you pause for reconsideration.

You are participating in the denial of my freedoms of conscience, religion, thought, belief, opinion and expression, and my rights of life, liberty, security of the person, and equality.

You are participating in the denial of my right of informed consent. Everyone has the right to decide what, if anything, should be done with their body. Everyone has the right to consent or refuse medical treatments. Coerced consent is no consent at all. Consent must be voluntary.

Informed consent is impossible in these circumstances, where the vaccines are still under study, all the side effects have not been discovered let alone published, and there are no known studies of the long-term effects.

You are participating in the erasure of my right to medical privacy, demanding to know my vaccination status, and effectively coercing me to disclose my personal health information in the faint hope of being exempted from coerced vaccination.

These vaccine mandates will ultimately fall before the law. My constitutional rights and freedoms, including my rights of informed consent and medical privacy will not be overthrown by these novel vaccine mandate policies of transitory governments chasing public opinion – and misreading public opinion at that.

You are undoubtedly already aware of people in your own circles who have died or been injured by the vaccines. By now the scientific evidence is clear, and you know, or ought to know, that:

1. the vaccines have not been proven safe and effective;
2. the vaccines do not prevent the risk of infection or transmission;
3. unvaccinated people have not been proven a greater hazard in the workplace or community than vaccinated people;
4. unvaccinated persons do not pose a greater risk than vaccinated persons of transmitting to vaccinated persons;

You will not be able to discharge your evidentiary burden of disproving the vaccine facts listed above, in defending yourself against liability. You will not be able to demonstrate any justification for your role in forcing me to be vaccinated or lose my employment and career.

Nevertheless, you have persisted in playing a role in violating my legal rights in order to coerce me to be vaccinated. Accordingly, you will be liable for the damage you cause.

Again, I am coming to you in the hope that you will recognize your error and reverse course, cease and desist from your illegal activities and avoid the liability described in this letter.
